**OPERATIONAL DIRECTIVE NO. 97-59**

**Last Amended: October 25, 2002**

**Effective: July 29, 2011**

**SUBJECT: PARKING RESTRICTIONS FOR NON-OPERATING AIRCRAFT AT MIAMI INTERNATIONAL AND GENERAL AVIATION AIRPORTS**

**PURPOSE:** To establish parking restrictions for non-operating aircraft at Miami International Airport (the Airport) in order to enhance the safety of airport users.

**I. AUTHORITY:**

- A. Chapter 25 of the Miami-Dade County Code, Miami-Dade Aviation Department (MDAD) Rules and Regulations, Section 25-10.24
- B. Miami-Dade Aviation Department Authorized Schedule of Rates, Fees and Charges

**II. DEFINITIONS:**

- A. **Non-operating aircraft:** Any aircraft located on the airport, whether on tenant leasehold or a public area, without a current certificate of airworthiness issued by the Federal Aviation Administration, and no substantial repair work being performed for more than 60 days.
- B. **Public area:** Non-leased areas.

**III. BACKGROUND:**

The Board of County Commissioners has determined that non-operating aircraft and component parts pose a danger to the life and safety of users of the Airport because they can be blown about in storms, become fire hazards, be subjected to vandalism, and may interfere with orderly and rapid emergency response efforts of firefighters, police, and ambulance services.

**IV. POLICY RESTRICTIONS:**

- A. No person shall park or store non-operating aircraft on Airport property, including leased premises, for more than 60 days without written authorization from the Miami-Dade Aviation Department.

- B. Non-operating aircraft parked on tenant leasehold property cannot be repositioned to a public area without the prior approval of the on-duty Airside Ramp Control Senior Agent at MIA or the General Aviation Supervisor at the GA Airports. Permission must be obtained by calling (305) 876-7001 at MIA; (305) 869-1662 at OPF or (305) 869-1702 for TMB and X51. The Senior Agent or GA Supervisor will also notify the Finance Division Revenue Section by email at the time the permission is granted.
- C. Approval to park non-operating aircraft in a public area shall not exceed 48 hours.
- D. All parking charges will accrue to the operator of record with the Miami-Dade Aviation Department.

**V. EFFECTIVE DATE:**


This OD shall become effective 15 days after having been filed/recorded with the Clerk of the Circuit Court as Clerk of the County Commission. The OD shall remain in effect until revoked or modified.

**VI. AMENDMENTS:**

**VII. SEVERABILITY:**

If any court of competent jurisdiction determines that a provision in this OD is illegal or void, the remainder of this OD shall continue in full force and effect.
