A. The following is a change to the Bid document.

Please see Addendum No. 2, Item B.

~~The Bid process anticipates disclosure of materials and communications from the County that are confidential in nature and Proposers will be required to execute Miami-Dade Aviation Department forms and undergo a background check prior to receiving such material and communications. Proposer(s) must provide a copy of a current, government issued, picture identification (e.g., Driver's License), documentation that they are licensed architect, engineer, or contractor who may perform work on, or related to, the Project, and sign and notarize the Acceptance of Sensitive Security Information Non-Disclosure Affidavit (<http://www.miami-airport.com/bids.asp>) certifying that the company and each authorized employee agrees, that in accordance with Florida Statutes § 119.071(3)(b) and one or more of the following Florida Statutes, § 281.301 and § 331.22, to maintain the information contained in the Bid Documents as being exempt from the provision of Florida Statute § 119.07(1) and § 24(a), Article I of the State Constitution, and a deposit in the amount of \$500 on March 29, 2022 at the Pre Bid Conference. Once vetted and approved by Department of Homeland Security, the Transportation Security Administration, Proposer(s) will be provided a secured link to the documents and instructions for viewing via email. No photographs and/or copying of the documents will be allowed.~~

~~Failure to adhere to agreed upon handling of the Documents deemed Sensitive Security Information to the Miami-Dade Aviation Department, will be reported to the Department of Homeland Security, the Transportation Security Administration, and local Law Enforcement Investigating Authority. Furthermore, the Proposer(s) will forfeit its deposit of \$500 and shall not be allowed to participate in any future confidential solicitations until such time that the Proposer has taken corrective actions satisfactory to Miami-Dade County.~~

B. Non-SSI Bid Document

C. Question and Answers

1. I would like to inquire if the Baggage division of R & B can participate in one of the Construction teams for project V043A, or are we precluded from participating because we did the Low Voltage design for the project.

Ross & Barrazini is precluded from participation on this project.

2. Please name all firms precluded from participation on the project.

No contract for the construction of a project shall be awarded to the firm that designed the project or its subsidiaries or affiliates. Moreover, the following firms are precluded from participation:

- **Bermello Ajamil & Partners**
- **Ross & Barrazini**
- **JSM Airport Consultants**

3. Is Sustainability/LEED Certification applicable to this project?

Any material provided in MIA Terminal needs to follow the DGM (Design Guideline Manual). The Bid is subject to the following provisions among others:

- **Sustainability/LEED Certification: This project is not to be LEED certified.**

4. I am wondering if you have an estimated budget and start date for the Miami International Airport (MIA) Central Terminal Ticket Counters, Conveyors, and K-1 doors for TC 12 through TC 17 project (# MDAD-CIP-V043A-4)?

Please refer to the Small Business Development Project Worksheet (MDAD-CIP-V043A-4 Volume I, pdf page 69) for the estimate project cost. The Notice to Proceed is expected around Fall 2022.

5. We do not have permanent badges at this point so we will need temporary. I'm assuming that we can work on getting the permanent badges once we're on board for projects?

6. I am a small business owner and Florida licensed contractor. I want to provide a bid for a portion of the work on the above referenced Project to one of the Contractors that plans on bidding. However, I need to view the plans and technical specifications in order to prepare my bid estimate. I understand that currently I am not allowed to view the plans and technical specs for security reasons.

7. Can the SSI docs be shared with a proposed sub that already does work at MIA?
